1. OVERVIEW

A meme with a message. A token with a structure.

DOBE is a meme-inspired crypto project that challenges both the way we see certain dog breeds—and how we use memes in Web3.Built around the misunderstood image of the Doberman, DOBE turns stereotype into identity, and spectacle into substance.

Rather than rely on empty hype, the project is structurally designed to reflect value through action:

- 30% OF THE TOTAL SUPPLY IS BURNED ACROSS 10 FIXED STAGES.
- 3% IS DONATED TO REAL-WORLD DOG SHELTERS, TRANSPARENTLY RECORDED ON-CHAIN.
- ONLY 10% IS OFFERED THROUGH PRESALE, REINFORCING SCARCITY FROM THE OUTSET.

DOBE does not operate as a DAO.

It is not an investment contract, nor a promise of returns. It's a purpose-built meme asset—anchored in culture, designed for circulation, and committed to small but real change

.As more public figures and communities stand alongside misunderstood breeds, DOBE adds one more voice: not by being loud, but by being deliberate.

2. STORY & IDENTITY

Strength means nothing without purpose.

DOBE is a token built around a misunderstood figure. Its name is inspired by the Doberman—a breed often misjudged not because of what it does, but because of how it looks.

Dobermans are intelligent, loyal, and deeply bonded to their companions. Yet the media has long distorted that image—emphasizing intimidation over trust, and leading to fear, avoidance, and ultimately, abandonment.

DOBE exists to challenge that cycle.

This project uses the language of meme culture, but anchors it in structure, meaning, and measurable outcomes. It's not about trend—it's about transformation.

- 30% of the total supply is burned to create scarcity with purpose and value through deliberate reduction.
- 3% is donated to verified dog shelters as part of a scheduled, on-chain model tied directly to each burn phase.
- Only 10% is allocated to presale, to ensure rarity, reduce speculation, and protect long-term holders.

These aren't marketing decisions—they're expressions of identity. The Doberman doesn't symbolize fear—it stands for focus. Its misunderstood nature mirrors the way memes are often treated: consumed, discarded, forgotten. But DOBE offers another path—circulation with responsibility, visibility with meaning.

Public figures around the world live alongside Dobermans—not to make a statement, but simply to share their lives with them. In doing so, they reshape perception through presence alone. And for that quiet kind of impact, we're sincerely grateful.

3. TOKENOMICS



Only 10% of the total supply is allocated to the presale. This limited allocation minimizes short-term speculative pressure and enhances long-term value for holders. It ensures scarcity for early participants while working in parallel with liquidity and burn strategies to create a stable environment.



Reserved for liquidity provisioning on both DEX and CEX. This allocation ensures smoother price discovery, stable trading conditions, and sufficient depth for market participants.



Scheduled to be burned in 10 phases over 1 year following CEX listing. A total of 30% of the supply will be permanently removed, introducing deflationary pressure and supporting token value over time.



DOBE prioritizes brand-oriented community building over short-lived virality. This allocation will support cinematic content production, user-driven campaigns, and reward-based distribution. The goal is to establish DOBE not just as a meme, but as a participatory brand with lasting narrative and cultural presence.



3% is allocated to donations supporting verified dog shelters, distributed in sync with each burn phase. The remaining 7% is reserved for the core team, with a 12-month lock-up period. This dual-purpose pool reflects both the project's values and its operational commitment.

4. BURN PLAN

Scheduled Supply Reduction

DOBE employs a time-based burn mechanism designed to reduce supply gradually and predictably. A total of 30% of the total token supply will be permanently burned over 10 phases, beginning shortly after CEX listing and continuing over the course of one year. This structure minimizes short-term volatility while increasing long-term scarcity, reinforcing holder confidence and providing a deflationary foundation for the token economy.

5. DONATION MECHANISM

Structured Giving Aligned with Scarcity

- DOBE's donation model is not automated or tied to a passive accumulation wallet. Instead, it is deliberately linked to the project's burn schedule—ensuring that each reduction in token supply is mirrored by a contribution to a real-world cause.
- After each of the 10 scheduled burn phases, a donation equivalent to 0.3% of the total token supply is made manually the following day.
- Over time, this adds up to a total of 3% of the supply donated across 10 phases.
- This mechanism reflects DOBE's belief that value creation should include value circulation.
- It's not a symbolic gesture; it's a recurring, scheduled action aligned with token movement.
- All donations are executed directly on the BNB Chain, and each transaction is transparently disclosed in an on-chain verifiable format.
- Future donation recipients will be publicly disclosed, and community input may guide the selection of shelter partners going forward.

5.1 Candidate Selection Criteria

Every candidate listed below was selected based on specific criteria that reflect the project's values and commitment to real-world impact:

1. Verified Nonprofit Status

Legally registered organizations with clear, transparent financial and operational records.

2.Direct Animal Welfare Impact

Each group is actively involved in rescuing, rehabilitating, or protecting companion animals especially dogs.

3.Proven Track Record

Not just intention, but demonstrated results—whether in shelters, adoption, education, or advocacy.

4.Geographic Diversity

To ensure global reach and local relevance, the candidates span the U.S., Europe, and global initiatives.

5.Ethical and Philosophical Alignment

All organizations reflect DOBE's broader goals: social contribution through movement, responsibility, and structured giving.
